## Introduction

Certification under the Estonian Forest Certification Scheme shall be carried out by third party certification bodies, which are accredited by a national accreditation body. The national accreditation body in Estonia is the Estonian Centre for Standardisation and Accreditation, which is also a member of the European Co-operation for Accreditation.

EFCC notification establishes a necessary link between accredited certification bodies and the owner of the Estonian Forest Certification Scheme and allows certification bodies to issue EFCC recognised certificates.

After the entry into force and the end of the transition period, this procedure replaces the 2015 version of the EFCC notification of certification bodies operating chain of custody and forest management certification in Estonia against the requirements of the Estonian Forest Certification Scheme.

## 1 Scope

This document describes procedures for the issuance of EFCC notification to certification bodies operating

a) forest management certification against the requirements of the Estonian Forest Certification Scheme

and/or

b) Chain of Custody certification in Estonia.

This document has been approved by the Board of Directors of the EFCC and shall be applied to all certification bodies carrying out forest management and/or chain of custody certification against the Estonian Forest Certification Scheme.

### **3 Terms and Definitions**

#### **Accredited certificate**

A certificate issued by a certification body within the scope of its accreditation which bears the accreditation body's symbol.

#### **Organization**

A legal or natural person holding an accredited certificate.

#### **EFCC**

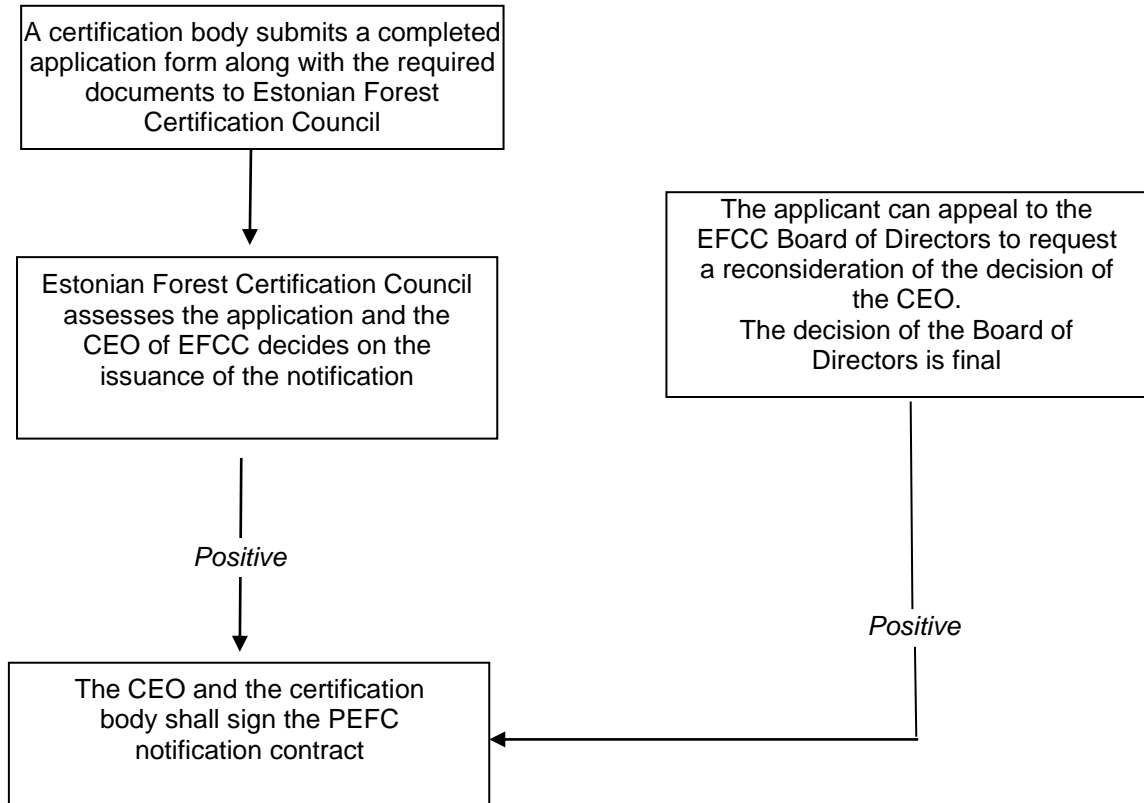

### **4 Conditions for Estonian Forest Certification Council notification**

The certification body applying for EFCC notification shall:

- be a legal entity;
  - agree to be listed on the publicly available PEFC Council's Information and Registration System including the certification body's identification data and/or other data as specified by PEFC GD 1008, PEFC Information and Registration System – Data Requirements);
  - sign a notification contract with Estonian Forest Certification Council (Appendix 1).
- a) The certification body applying for the right to be a EFCC notified certification body operating forest management and group forest management certification against the requirements of the Estonian Forest Certification Scheme shall have valid accreditation, issued by an accreditation body with membership within the European Co-operation for Accreditation (EA) or the International Accreditation (IAF). The accreditation shall be issued against ISO/IEC 17021-1 and the scope of the accreditation shall explicitly include the requirements of PEFC EST 1003:2022, PEFC Estonia Sustainable Forest Management, PEFC EST 1002:2022, Group Forest Management Certification and PEFC ST 2001:2020, PEFC Trademarks Rules – Requirements.
- b) The certification body applying for the right to be a EFCC notified certification body operating chain of custody certification against the requirements of the Estonian Forest Certification Scheme shall have valid accreditation, issued by an accreditation body that is with membership within the European Co-operation for Accreditation (EA) or the International Accreditation (IAF). The accreditation shall be issued against ISO/IEC 17065 and the scope of the accreditation shall explicitly include PEFC ST 2002:2020, Chain of Custody of Forest Based Products – Requirements and PEFC ST 2001:2020, PEFC Trademarks Rules – Requirements.

## **6 Obligations of the notified certification body**

The EFCC notified certification body shall:

1. Pay Estonian Forest Certification Council an annual notification fee for every certificate when invoiced by EFCC. Tariffs for the annual notification fee are set and may be changed by Estonian Forest Certification Council during the validity of the contract. Any change to the contract between the Estonian Forest Certification Council and the notified certification body resulting from a change in the rates will normally take effect the year following that in which the Estonian Forest Certification Council has informed the certification body, in writing, of the change. Extraordinary changes in the annual notification fee structure and tariffs are possible if mutually agreed upon by the Estonian Forest Certification Council and affected certification bodies.
2. Agree to be listed on the publicly available PEFC Council's Information and Registration System including the certification body's identification data and/or other data as specified by PEFC GD 1008, PEFC Information and Registration System – Data Requirements.
3. Inform certified organisations about the range of information to be reported to Estonian Forest Certification Council and about the fact that the information is to be made publicly available on the PEFC Information and Registration System.
4. Inform the certified organisations of the notification fees established to certificate holders by EFCC and about the procedure for obtaining a PEFC Trademark usage license.

### **6.1 Forest Management certification**

A notified certification body operating forest management certification shall:

1. Have and keep valid accreditation issued in compliance with Estonian Forest Certification Scheme and inform Estonian Forest Certification Council immediately about any changes in the accreditation. The certification body shall, upon request, provide updated evidence that it still meets the requirements of valid accreditation.
2. Carry out forest management certification against PEFC Estonia Sustainable Forest Management Standard, PEFC EST 1003:2022 within the scope of the valid accreditation.
3. Provide Estonian Forest Certification Council immediately and truthfully with a completed reporting form for each PEFC forest management certificate and every site covered by a group certificate, issued under the scope of notification and on any changes concerning reported certificates.
4. Provide Estonian Forest Certification Council, upon request, with a list of forest management certificates issued under the scope of notification contract concluded with Estonian Forest Certification Council, including the information defined in the reporting form in the appendix to this document.

## **6.2 Chain of Custody certification**

A notified certification body operating chain of custody certification shall:

1. Have and keep valid accreditation issued in compliance with Estonian Forest Certification Scheme and inform Estonian Forest Certification Council immediately about any changes in the accreditation. The certification body shall, upon request, provide updated evidence that it still meets the requirements of valid accreditation.
2. Carry out PEFC chain of custody certification against PEFC ST 2002:2020, *Chain of Custody of Forest and Tree Based Products - Requirements* within the scope of the valid accreditation.
3. Provide Estonian Forest Certification Council immediately and truthfully with a completed reporting form for each chain of custody certificate and every site covered by a multi-site certificate, issued under the scope of notification and on any changes concerning reported certificates.
4. Provide Estonian Forest Certification Council, upon request, with a list of certificates issued under the scope of notification contract concluded with Estonian Forest Certification Council, including information defined in the reporting form in the appendix to this document.

## **7 Validity of the notification**

The notification right of a certification body is valid for the period of the validity of the certification body's accreditation. The notification right can be terminated or suspended immediately by Estonian Forest Certification Council, if the notification contract is violated.

## 8.1 Notification Contract

### Notification Contract

Between

(1) ***Estonian Forest Certification Council***, hereinafter ***EFCC*** having its registered office at Toompuiestee 24, 10149 Tallinn, Estonia

and

(2) ***[Certification body]***, hereafter the “Notified Certification Body”, having its registered office at *[address]*

Whereas the Notified Certification Body is operating Chain of Custody certification and/or Forest Management certification *[none applicable to be deleted]*, recognised by Estonian Forest Certification Council;

Whereas EFCC is the governing body of the Estonian Forest Certification Scheme and has the right to issue PEFC trademark licences on behalf of PEFC based on the administration contract signed with the PEFC Council;

Whereas the Notified Certification Body has been granted the right of notification, and EFCC recognises certificates issued by the Notified Certification Body within the scope of valid accreditation to organisations which are registered in Estonia, and international sites participating in multi-site Chain of Custody certifications of these organisations.

Now, therefore the above said parties agree to the following:

#### Article 1

##### Definitions:

##### 1. Forest management certification

This is based on *PEFC Estonia Sustainable Forest Management Standard*, PEFC EST 1003:2022, which is a part of the Estonian Forest Certification Scheme and forms a part of this notification contract and can be found on EFCC webpage. EFCC can alter or replace this standard with another document.

##### 2. Group certification

This is based on PEFC EST 1002:2022 standard, *Group Forest Management Certification – Requirements* which is a part of the Estonian Forest Certification Scheme and forms a part of

this notification contract and can be found on EFCC webpage. EFCC can alter or replace this standard with another document.

3. Requirements for certification bodies operating PEFC forest management certification

This is based on PEFC EST 1004:2022, *Requirements for Certification Bodies operating Certification against the PEFC International Chain of Custody Standard* which is a part of the Estonian Forest Certification Scheme and forms a part of this notification contract and can be found on EFCC webpage. EFCC can alter or replace this standard with another document.

4. Chain of Custody of Forest Based Products – Requirements

This is based on PEFC ST 2002:2020, *Chain of Custody of Forest and Tree Based Products - Requirements*, which forms a part of the Estonian Forest Certification Scheme and forms a part of this notification contract and can be found on EFCC webpage. The standard has been approved by PEFC Council and adopted by EFCC.

5. Requirements for Certification Bodies operating certification against the PEFC International Chain of Custody Standard

This is based on PEFC ST 2003:2020, *Requirements for Certification Bodies operating Certification against the PEFC International Chain of Custody Standard against the PEFC International Chain of Custody Standard*, which forms a part of this notification contract and can be found on EFCC webpage. The standard has been approved by PEFC Council and adopted by EFCC.

6. Tariffs of the Notification Fee of EFCC

These are the tariffs set by the EFCC and EFCC can alter these tariffs or replace these with another document. The tariffs of the EFCC Notification Fee form a part of this notification contract and can be found on EFCC webpage.

7. Notification Reporting Form of the Certificate

This is Appendixes 3 and 4 to the EFCC notification procedure, which forms a part of this notification contract.

## **Article 2: Responsibilities of the Notified Certification Body**

### **The Notified Certification Body is obliged to:**

1. Pay EFCC the annual notification fee for every certificate when invoiced by EFCC. The amount of the fee is set by EFCC and can be changed by EFCC during the validity of the contract. Any change to the contract between EFCC and the notified certification body resulting from a change in the rates will take effect the year following that in which the EFCC has informed the Notified Certification Body, in writing, of the change.
2. Agree to be listed on the publicly available internet database PEFC Information Register, as

specified by PEFC GD 1008, PEFC Information and Registration System – Data Requirements, including the certification body’s identification data and/or other data.

3. Inform certified organisations about the range of information to be reported to Estonian Forest Certification Council and about the fact that this information shall be made publicly available on the internet database PEFC Information Register.
4. Inform the certificate holder about the procedure for obtaining a PEFC Logo usage license from Estonian Forest Certification Council.

**The Notified Certification Body operating Forest Management certification is obliged to:**

1. Have and keep valid accreditation issued in compliance with Estonian Forest Certification Scheme and immediately inform Estonian Forest Certification Council about any changes in the accreditation. It shall provide, upon request, updated evidence that it still meets the requirements of valid accreditation.
2. Operate forest management certification against PEFC Estonia Sustainable Forest Management Standard within the scope of the valid accreditation.
3. Provide Estonian Forest Certification Council immediately and truthfully with a completed reporting form for each forest management certificate and every site covered by a group certificate, issued within the scope of notification contract and on changes concerning reported certificates.
4. Provide Estonian Forest Certification Council, upon request, with a list of forest management certificates issued within the scope of the notification contract with Estonian Forest Certification Council, including information defined in the reporting form in the appendix to this document.

**The Notified Certification Body operating Chain of Custody certification is obliged to:**

1. Have and keep valid accreditation issued in compliance with Estonian Forest Certification Scheme and immediately inform Estonian Forest Certification Council about any changes in the accreditation. It shall provide, upon request, updated evidence that it still meets the requirements of valid accreditation.
2. Operate PEFC chain of custody certification against PEFC ST 2002:2020 within the scope of the valid accreditation.
3. Provide Estonian Forest Certification Council immediately and truthfully with a completed reporting form for each chain of custody certificate and every site covered by a multi-site certificate, issued within the scope of notification contract and on changes concerning reported certificates.
4. Provide Estonian Forest Certification Council, upon request, with a list of chain of custody certificates issued within the scope of the notification contract with Estonian Forest Certification Council, including information defined in the reporting form in the appendix to this document.

### **Article 3: Responsibilities of EFCC**

1. EFCC recognises the certificates issued by the Notified Certification Body in compliance with this contract and provides the holders of the certificates with access to a PEFC Trademark usage license under the conditions specified by EFCC.
2. EFCC is obliged to inform the Notified Certification Body of any changes to the regulations and documentation which affect this contract.

### **Article 4: Contract Termination**

1. Either party may terminate the contract with three-month prior notice provided in writing and digitally signed and sent to the e-mail address info@pefc.ee or sent by registered letter to the address specified in the contract.
2. EFCC may suspend the contract with immediate effect, if there are reasons to believe that any provision of the notification contract is not being adhered to.
3. Withdrawal, suspension or the end of the validity of the Notified Certification Body's accreditation, will result in automatic termination of the contract with effect on the same date as the withdrawal, suspension or the end of the validity of the accreditation.
4. The notification fee shall not be refunded to the Notified Certification Body in case of temporary suspension or termination of the contract according to sections 1, 2 and 3 of the Article 4.
5. The EFCC is not obliged to pay compensation for any costs or other damages which any temporary suspension or termination causes to the Notified Certification Body.

### **Article 5: Validity of the Contract**

The contract enters into force when it has been signed by both parties. The Contract is valid for the period of validity of the accreditation.

### **Article 6: Governing Law - Jurisdiction**

1. This contract is subject to the law of the Republic of Estonia.
2. Any disputes arising from this agreement shall be settled by Harju County Court.
